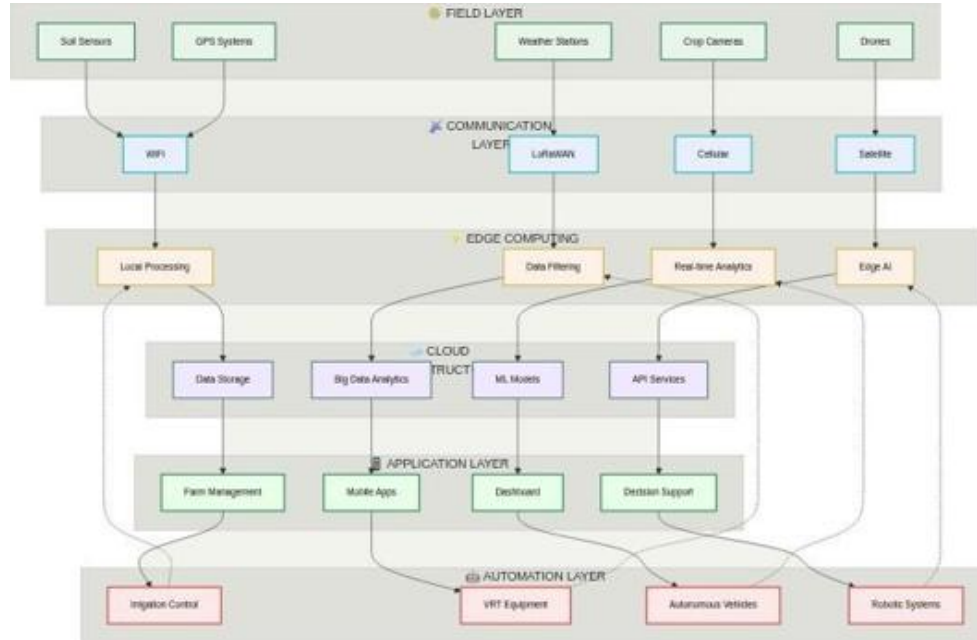


Fig. 1: Integrated System Architecture for Precision Agriculture

D. IoT System Architectures and Communication Protocols

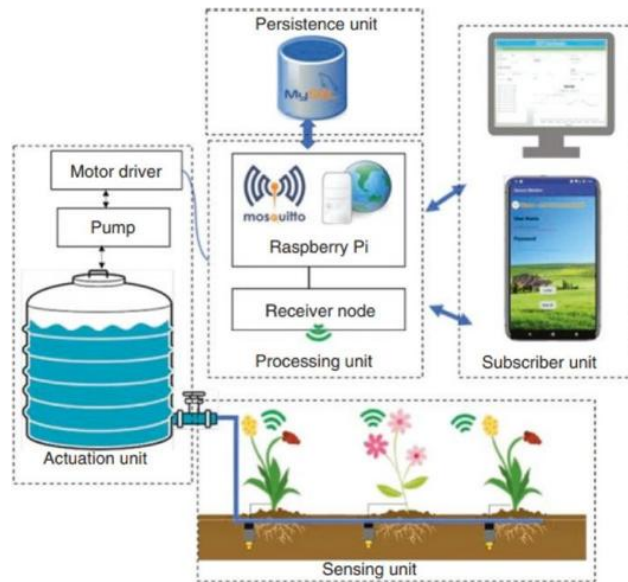


Fig. 2: Architecture of an intelligent smart irrigation system integrating sensing, processing, actuation, and remote monitoring units using IoT and embedded computing

88.2–96.6%).

Models with transfer learning pre-trained on ImageNet fell between 88–92% in terms of accuracy.

Field-Deployment Performance Reality Of the 12 studies that reported both lab and field results, the drop-off is hard to ignore:

- High-res professional images: accuracy remained at $95.2\% \pm 2.1\%$.

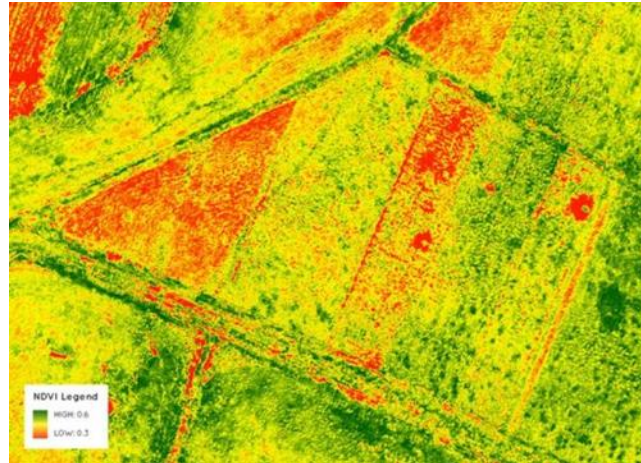


Fig. 3: NDVI map showing crop health variability using satellite remote sensing in agriculture.

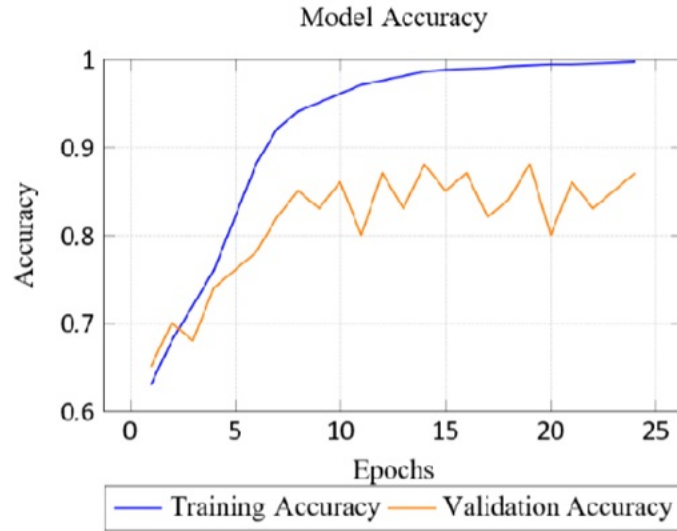


Fig. 4: Training and Validation Accuracy over Epochs
